- (3) If there is a hillside involved in development (10% or greater grade to building envelope) there can be little to no gouging of hillside without plans submitted by a licensed engineer. Grading plans must be approved by the County Engineer.
- (4) The property owner is responsible for obtaining any other required permit applicable to this project.
- (5) Private Roads will need to be designed and inspected by a licensed engineer. The fees associated with this application do not include engineer fees. A roadway verification sheet will need to be signed by an engineer prior to final approval. The Elmore County Engineer shall approve all roadway construction plans prior to an application being forwarded to the Commission for review.
- (6) Per section 6-17-1 of the Elmore County Zoning and Development Ordinance: Elmore County will not approve development applications, land splits, or any type of zoning related application unless improved roads are provided to all properties.
- (7) The Elmore County Engineer will review road drawings for this road. By signing this application the property owner accepts all fees incurred by the County Engineer. A deposit for services is required. (Note: The County Engineer is a contract employee with Elmore County).
- (8) The process to build a private road is complex. The Land Use & Building Department may have additional requirements.
