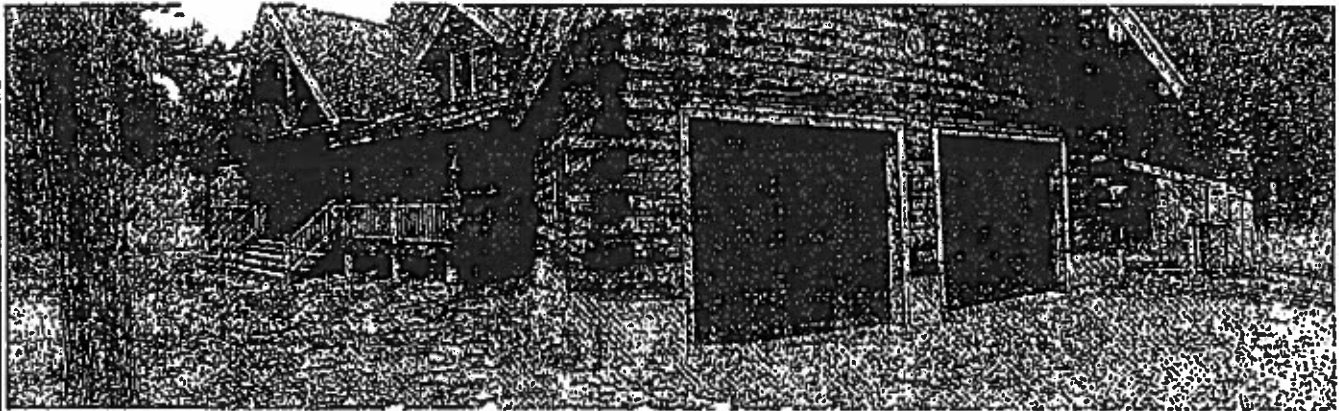

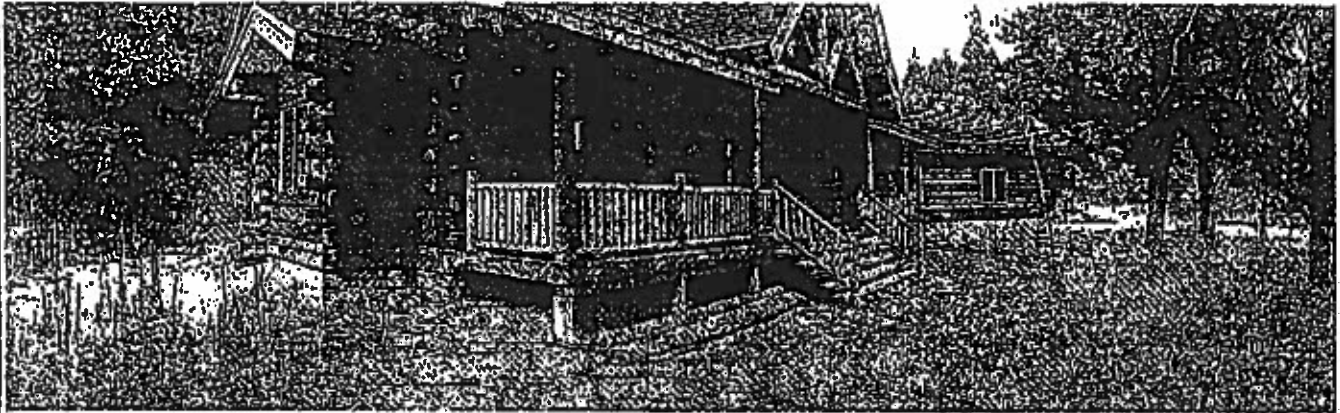

Photo One Caption EAST SIDE

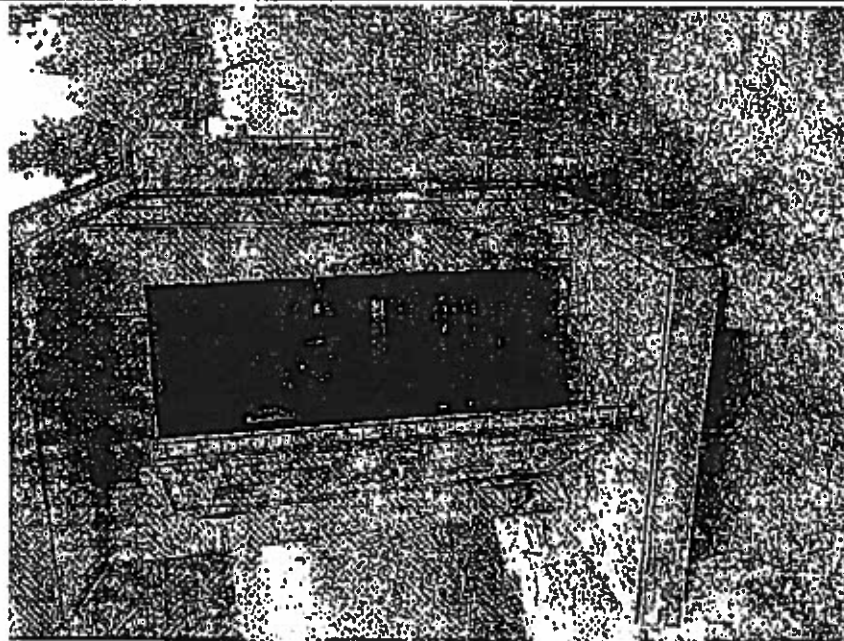
