COME WITHIN THE PURVIEW OF THIS ORDINANCE; PROVIDING THAT THE PROVISIONS OF THIS ORDINANCE SHALL HAVE NO APPLICATION WITHIN THE LIMITS OF ANY INCORPORATED CITY WITHIN ELMORE COUNTY THE LIMITS OF ANY INCORPORATED CITY WITHIN ELMORE COUNTY, IDAH PROVIDING FOR UNLAWFUL ACTS; PROVIDING FOR A PENALTY; PROVIDING FOR A REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FURTHER A LIVE TO THE REPORT OF THE PROPERTY OF THE PR FOR A SAVINGS CLAUSE AND EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF E

Section 1. For the purpose of preventing persons in Elmore County under the age of 13 years from running away or statempting to run away from home, and in order to promote the safety and welfare of the residents of Elmore County, State of Idako, this Ordinance is hereby enacted.

Section 2. UNLAWFUL ACTS: It shall be unlawful for any person under the age of 18 years, living or found in Elmore County, State of Idaho, to attempt to run away or to run away from his parents, guardian or other legal custodian, or to be or remain a person who has run away from his parents, guardian or other legal custodian or to be a person who committed or has committed any act or acts placing him beyond the control of his parents, guardian or other legal custodian.

Section 3. UNLAWFUL ACTS: It shall be unlawful for any person by any act or neglect to encourage, aid or cause any person under the age of 18 years to come within the purview of Section 2 of this Ordinance.

Section 4. PENALTIES: A violation of this Ordinance sha be punishable by imprisonment in the Elmore County Jail for a period of not to exceed 30 days or by a fine not to exceed \$1,000.00, or by both such fine and imprisonment

Section 5. The provisions of this Ordinance shall not apply within the incorporated limits of any city in Elmore County Idaho, and shall apply only to those transactions arising outside of the incorporated limits of any city located in Elmore County, Idaho.

Section 6. REPEAL OF CONFLICTING ORDINANCES: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 3. EFFECTIVE DATE: This Ordinance shall be in full force and effect from and after its passage, approval and publication.
