## ELMORE COUNTY ORDINANCE NO. \_80-2

AN ORDINANCE RESTRICTING THE USE OF WATERCRAFT ON A PORTION OF THE SOUTHFORK OF THE BOISE RIVER, TO PROVIDE FOR PENALTIES FOR VIOLATION AND PROVIDING FOR SEVERABILITY;

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF ELMORE COUNTY, IDAHO, IN LAWFUL MEETING ASSEMBLED:

Section 1. For the purpose of providing for the safety and health and promoting and protecting the health, safety and general welfare of the citizenry of Elmore County and the inhabitants thereof, and for the protection of persons and property therein, this Ordinance is hereby enacted to restrict the use of motorized water craft on a portion of the South Fork of the Boise River located in Elmore County, State of Idaho, which is a hazardous boat traffic area.

Section 2. From and after July 9, 1980, no person shall operate or give permission for the operation of any motorized boat, watercraft or vessel on that portion of the South Fork of the Boise River in Elmore County, Idaho, located between the Black's Creek Bridge, which is located in Section 34, Township 3 North, Range 6 East, Boise Meridain, Elmore County, Idaho, and Anderson Ranch Dam, which is located in Section 1, Township 1 South, Range 8 East, Boise Meridian, Elmore County, Idaho.

Section 3. As used in this Ordinance, the term motorized boat, watercraft or vessel means any vessel propelled by machinery, whether or not such machinery is the principal source of propulsion.

Section 4. A violation of Section two (2) of this Ordinance shall be a misdemeanor, punishable by imprisonment in the Elmore County jail not exceeding six (6) months or by a fine not exceeding Three Hundred Dollars (\$300.00) or both.

Section 5. The provisions of this act are hereby de-

clared to be severable and if any provision of this act or the application of such provision to any person or circumstance is declared invalid for any reason, such declaration shall not affect the validity of remaining portions of this act.

PASSED, Under suspension of the rules, at a regular meeting of the Elmore County Board of County Commissioners in the City of Mountain Home, County of Elmore, State of Idaho, held on the 9 th day of June, 1980, upon which a roll call vote was duly taken and said Ordinance duly enacted by a unanimous vote as an Ordinance of Elmore County, Idaho.
