## ORDINANCE NO. 83-3

AN ORDINANCE SETTING A REASONABLE FEE, PURSUANT TO IDAHO CODE SECTION 50-1305, FOR THE CHECKING OF PLAT REQUIREMENTS AND CERTIFICATION THEREOF AND SETTING FEES FOR PRELIMINARY AND FINAL PLAT APPLICATIONS FILED WITH THE ELMORE COUNTY PLANNING AND ZONING COMMISSION.

BE IT ORDAINED by the Board of County Commissioners of Elmore County, Idaho, in lawful meeting assembled:

Section 1. The Board of County Commissioners of Elmore County, Idaho, pursuant to Idaho Code Section 50-1305, desires to provide for the collection of a reasonable fee from the subdivider for a qualified surveyor or engineer, chosen and required by the County of Elmore to survey and sufficiently check plats and computations thereon, to determine that legal requirements are met, and to certify said compliance on said plat. Said fee is hereby set in the amount of fifty dollars (\$50.00) per plat plus one dollar (\$1.00) per lot appearing on said plat and is to be paid to the Elmore County Recorder prior to the recording of said plat.

Section 2. The Board of County Commissioners of Elmore County, Idaho, pursuant to Article III, Section C5 of Elmore County Ordinance No. 73-12, the Subdivision Ordinance, desires to provide for the collection of a reasonable fee from the subdivider for the filing of a preliminary plat application with the Elmore County Planning and Zoning Commission. Said fee is hereby set in the amount of fifty dollars (\$50.00) per plat plus one dollar (\$1.00) per lot appearing on said plat and is to be paid to the County of Elmore at the time of filing said preliminary plat application.

Section 3. The Board of County Commissioners of Elmore County, Idaho, pursuant to Article III, Section D3 of Elmore County Ordinance No. 73-12, the Subdivision Ordinance, desires to provide for the collection of a reasonable fee from the subdivider for the filing of a final plat application with the Elmore County Planning and Zoning Commission. Said fee is hereby set in the amount of fifty dollars (\$50.00) per plat and is to be paid to the County of Elmore at the time of filing said final plat application.

Section 4. This Ordinance shall be in full force and effect from and after its approval, passage, and publication.

PASSED under suspension of rules, by a unanimous vote of the members of the full Board upon roll call vote at a regular meeting of the Board of County Commissioners of Elmore County, Idaho, held on the 23rd day of May, 1983, and duly enacted an Ordinance of Elmore County, Idaho.
