AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS, ELMORE COUNTY, IDAHO, ESTABLISHING THE TIME PERIOD WITHIN WHICH A DECISION MUST BE MADE FOLLOWING SUBMISSION OF AN APPLICATION FOR A LICENSE, RENEWAL, OR TRANSFER THEREOF, FOR BEER, WINE, AND LIQUOR; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED By the Board of County Commissioners of Elmore County;

## SECTION 1: SHORT TITLE.

(1) This Ordinance shall be known as the "Elmore County Beer, Wine, and Liquor License Ordinance", and all other ordinances and parts of ordinances and resolutions in conflict herewith are repealed upon the effective date of this ordinance.

## SECTION 2: AUTHORITY AND PURPOSE.

- (1) This Ordinance is adopted pursuant to authority granted by Idaho Code, Sections 31-714, 31-801, 31-828, 23-908, 23-916, 23-933B, 23-1005A, 23-1015, 23-1315, 23-1317, and 23-1318.
- (2) The purpose of this Ordinance is to establish a time period within which a decision must be made by the Board of County Commissioners following submission of an application to them for beer, wine, and liquor licenses, renewals, or transfers thereof.

SECTION 3: TIME LIMITS FOR BEER, WINE, AND LIQUOR APPLICATIONS.

(1) The Board of County Commissioners shall act upon applications for beer, wine, and liquor licenses, or renewals or

transfers thereof, within thirty (30) days from the receipt of the application by the Board.

(2) The procedure for processing applications for beer, wine, and liquor licenses, and renewals or transfers thereof, shall be governed by Idaho Code Sections 23-908, 23-916, 23-933B, 23-1005A, 23-1015, 23-1315, 23-1317, and 23-1318 and any rules and regulations promulgated by the Board of County Commissioners in accordance with Title 67, Chapter 52 of the Idaho Code, the Administrative Procedure Act.

## SECTION 4: EFFECTIVE DATE.

This Ordinance shall be in full force and effect upon publication in a newspaper.

SUMMARY OF ELMORE COUNTY BEER, WINE, AND LIQUOR LICENSE ORDINANCE

Elmore County has enacted an Ordinance known as the Elmore County Beer, Wine, and Liquor License Ordinance which establishes a time period of thirty (30) days after submission of applications for issuance, renewal or transfer of beer, wine, and liquor licenses within which the Board of County Commissioners must act upon that application. The Ordinance, passed to implement a newly enacted Idaho statute, provides that the procedure to be followed in processing applications is that procedure established by Idaho Code Sections 23-908, 23-916, 23-933B, 23-1005A, 23-1015, 23-1315, 23-1317, and 23-1318, and provides further that any rules of procedure passed by the Board must be issued in compliance with the Administrative Procedure Act, Title 67, Chapter 52 of the Idaho Code.
