## ORDINANCE NO. 99-5

AN ORDINANCE AMENDING THE ELMORE COUNTY FLOOD DAMAGE
PREVENTION ORDINANCE OF 1995 AND PROVIDING FOR A MINIMUM
HEIGHT ABOVE FLOOD ELEVATION FOR NEW AND IMPROVED
CONSTRUCTION.

WHEREAS, Title 67, Chapter 65 of the Idaho Code and Article 12, Section 2 of the Idaho Constitution provide authority for Elmore County to adopt land use and regulation ordinances to protect the health, safety, and welfare of their citizens, and WHEREAS, the Board of Commissioners of Elmore County passed the Flood Damage and Prevention Ordinance of 1995; and

WHEREAS, The Elmore County Planning and Zoning Commission, after notice and hearing recommended an amendment of the Flood Damage Prevention Ordinance to the Board of Commissioners of Elmore County; and

WHEREAS, the Board of Commissioners of Elmore County after notice held a public hearing on the proposed ordinance amendment;

BE IT ORDAINED BY THE BOARD OF THE COUNTY COMMISSIONERS OF ELMORE COUNTY, IDAHO, IN LAWFUL MEETING ASSEMBLED:

Section 1: That Section 5.2-1(1) of the Elmore County Flood Damage Prevention Ordinance of 1995 be amended to read as follows:

"New construction and substantial improvement of any residential structure shall have the lowest floor, including basement, elevated to or above two feet (2') above base flood elevation."

Section 2: EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval, and publication.

PASSED, at a regular meeting of the Elmore County Board of County Commissioners in the City of Mountain Home, County of Elmore, State of Idaho, held on the 23rdday of August, 1999, upon which roll call vote was duly taken and said Ordinance duly passed by a unanimous vote as an Ordinance of Elmore County, Idaho.

A summary of the Ordinance shall be published in the Mt. Home News within one (1) month after passage.


