

COMMISSIONERS MEETING

AUGUST 26, 2013

The Elmore County Commissioners met in regular session on the above date in the Commissioners Room, basement of the Elmore County Courthouse, 150 South 4th East, Mountain Home, Idaho.

Present at the meeting were Chairman Al Hofer, Commissioners Bud Corbus and Wes Wootan. Also present were Civil Attorney Buzz Grant, Clerk Barbara Steele and Deputy Clerk Shelley Hooper.

Pete Wagner, representing the Department of Environmental Quality (DEQ) and Marty Jones, representing the Central District Health Department (CDH) appeared to discuss recovery efforts for the Pony Complex and Elk Complex fires. The process will be a joint effort between DEQ and CDH. Mr. Jones will be working on assessments of private water supplies for impacts from the fires. He will do on-site evaluations of wells and take water samples, with no cost to the residents. During the clean-up phase, Mr. Jones can direct residents on where to take the waste, or possible have a company come and pick up the waste. Chairman Hofer stated that trucks and dumpsters were taken to the Fall Creek and Lester Creek areas for clean-up efforts. Mr. Wagner discusses the issues of the proper disposal of household hazardous materials and debris, such as paint/solvent cans, refrigerators with freon or car batteries and tires. Mr. Wager stated that residents should wear dust masks during clean-up, as airborne dust from the fires will cause poor air quality in these areas. He also suggested that underground fuel tanks and septic systems should be checked before use, as any underground tanks could have been damaged by heavy equipment such as fire trucks or excavation equipment. Mr. Jones urged the commissioners to have residents contact either himself or Mr. Wagner with questions or concerns. Discussion followed.

Dave Humphreys, Extension Office, updated the group on the BAER (Burn Area Emergency Response) Team. The team discussed emergency stabilization of fire areas, with the objective of determining the need for emergency treatments to minimize threats to life or property or to stabilize and prevent degradation to natural and cultural resources resulting from the effect of the fires. The team has one week to do assessments, gather information and put a plan together. They then have to take action within one year. Rehabilitation efforts are taken within three years of containment of the fire, to repair or improve fire damaged lands unlikely to recover naturally, or to repair or replace minor facilities damaged by the fire, such as fences, campgrounds, signs, shade shelters, etc. There is a Silver Jackets Team, made up of several government agencies, which help to provide solutions to flood hazard issues and response and recovery planning. Carol Killian, Disaster Services Coordinator and Dale Nalder, Idaho Bureau of Homeland Security also appeared. Ms. Killian updated the Board of the Little Queens Fire. There was a back burn done that is holding the fire away from the Atlanta homes. Currently, the fire is 10% contained. Ms. Killian is following up on some new fires that were sparked started during a lighting storm last night and will report back to the board.

The monthly Department Heads meeting was held.

Alan Roberts, Extrication Department, appeared. His department has been quiet, having to respond to only a few accidents this month. They will be holding an extrication demonstration at Walmart and they also will be participating in recertification training with Elmore Ambulance Service in September.

Steve Dye, Juvenile Probation Director, appeared to give his monthly update. Mr. Dye reviewed his caseload report. There has been an increase in the number of community service hours, as there were more juveniles which were referred to the program.

Vence Parsons, Plant Facilities Manager, appeared to update the board of maintenance issues at the jail. He is in need of an office space and storage space at the jail. There is currently one full time and one part time maintenance positions at the jail. Mr. Parsons feels that there is enough work for two full time positions. Discussion followed.

Jennifer Crogg, Misdemeanor Probation, appeared to give the board her monthly report. There have been ten clients added to the case load and twelve were released or terminated from probation. The number of conditional release clients is thirty seven. They had one restitution case for August. Currently, there are thirty one clients enrolled in community service, which are clients on unsupervised probation only.

Wade Baumgardner, Veterans Services Officer, appeared. Mr. Baumgardner has been working on several intricate cases in the past month. He attended the annual Service Officers Training Conference in Boise. In the last month, his office has assisted twenty eight veterans, spouses or family members with VA issues. Mr. Baumgardner reviewed informational updates from the regional Office of Veterans Affairs in Boise.

Alan Christy, Land Use and Building Department Director, appeared to update the Board. His department issued ten building permits in the month of August. There were no Owyhee County permits issued in July. Currently, they have one pending building permit in Owyhee County and one pending building permit for Elmore County. The Planning and Zoning Commission has had full agendas with the recent applications. The expiration dates for Mayfield Townsite are approaching. Mr. Christy will provide the board more information at a later date.

Vence Parsons and DJ Remington appeared to discuss suggestions for jail maintenance operations. Mr. Remington stated that hard copy maintenance request forms are a must. They would like to purchase a lockable roll-around maintenance cart for tools and parts.

The monthly Elected Officials meeting was held.

Sheriff Rick Layher and Chief Deputy Mike Barclay updated the Board of the wildfires. Treasurer Rose Plympton appeared to update the Board. Her office is currently starting to work on the 2010 past due taxes.

Motion by Hofer, second by Corbus, to go into Executive Session pursuant to I.C. 67-2345(d) to discuss records exempt from disclosure. Roll call vote was taken.

THIRD EXTENSION OF DECLARATION OF LOCAL DISASTER EMERGENCY

AT A MEETING OF THE BOARD OF ELMORE COUNTY (the “County”) COMMISSIONERS (the “Board”), STATE OF IDAHO, ON THE 26TH DAY OF AUGUST, 2013, THE FOLLOWING RESOLUTION WAS ADOPTED, TO WIT;

WHEREAS, the Board, on August 9, 2013, passed Resolution No. 520-13 (“Initial Declaration”) declaring a state of local disaster emergency regarding the wild fires located in the County, referred to as the Pony Complex Fire and the Elk Complex Fire; and

WHEREAS, the declaration of local disaster emergency under Idaho Code is §46-1011(1), is limited in duration to seven days unless it is continued or renewed for a period in excess of seven days with the consent of the governing board of the political subdivision; and

WHEREAS, the Initial Declaration runs from August 9, 2013 through August 16, 2013; and

WHEREAS, the Board on August 12, 2013, adopted Resolution No. 521-13 (the “First Extension”) extending the declaration of local disaster from August 16, 2013 through August 23, 2013; and

WHEREAS, the First Extension contained a scrivener’s error and the Board corrected such error and restated the First Extension of the Declaration of Local Disaster Emergency by passing Resolution No. 522-13 (the “Corrected First Extension”) on August 15, 2013, extending the declaration of local disaster from August 16, 2013 through August 23, 2013; and

WHEREAS, the Board on August 19, 2013, adopted Resolution No. 523-13 (the “Second Extension”) extending the declaration of local disaster from August 23, 2013 through August 30, 2013; and

WHEREAS, the Board desires to further extend the declaration of local disaster emergency from August 30, 2013 through September 6, 2013; and

WHEREAS, the Board, pursuant to Idaho Code §46-1011, has the authority to declare a state of local disaster emergency regarding the County; and

WHEREAS, the Board has determined that the wild fires located in the County, commonly known and referred to as the Pony Complex Fire and the Elk Complex Fire, are a local disaster emergency; and

WHEREAS, a local disaster emergency exists in the County and the County requires state emergency assistance to supplement local efforts to protect life and property and to activate the response and recovery aspects of any and all applicable local or intergovernmental disaster emergency plans and to authorize the furnishing of aid and assistance thereunder; and

WHEREAS, the Board requests that the Governor of the State of Idaho, together with the other appropriate state officials, along with other appropriate federal officials, to make such declarations, and provide such assistance within County as required and allowed by law.

NOW, THEREFORE, BE IT RESOLVED, that Elmore County Board of Commissioners does hereby declare, pursuant to Idaho Code §46-1011, that a local disaster emergency exists in Elmore County, Idaho; and

BE IT FURTHER RESOLVED, that the Governor of the State of Idaho be advised of this local disaster emergency and is requested to take all action available for the amelioration of the above described local disaster emergency; and

WHEREAS, the declaration of local disaster emergency under Idaho Code is §46-1011(1), is limited in duration to seven days unless it is continued or renewed for a period in excess of seven days with the consent of the governing board of the political subdivision; and

WHEREAS, the Initial Declaration runs from August 9, 2013 through August 16, 2013; and

WHEREAS, the Board on August 12, 2013, adopted Resolution No. 521-13 (the “First Extension”) extending the declaration of local disaster from August 16, 2013 through August 23, 2013; and

WHEREAS, the First Extension contained a scrivener’s error and the Board corrected such error and restated the First Extension of the Declaration of Local Disaster Emergency by passing Resolution No. 522-13 (the “Corrected First Extension”) on August 16, 2013, extending the declaration of local disaster from August 16, 2013 through August 23, 2013; and

WHEREAS, the Board on August 19, 2013, adopted Resolution No. 523-13 (the “Second Extension”) extending the declaration of local disaster from August 23, 2013 through August 30, 2013; and

WHEREAS, the Board on August 26, 2013, adopted Resolution No. 525-13 (the “Third Extension”) extending the declaration of local disaster from August 30, 2013 through September 6, 2013; and

WHEREAS, the Board desires to further extend the declaration of local disaster emergency from September 6, 2013 through September 13, 2013; and

WHEREAS, the Board, pursuant to Idaho Code §46-1011, has the authority to declare a state of local disaster emergency regarding the County; and

WHEREAS, the Board has determined that the wild fires located in the County, commonly known and referred to as the Pony Complex Fire and the Elk Complex Fire, are a local disaster emergency; and

WHEREAS, a local disaster emergency exists in the County and the County requires state emergency assistance to supplement local efforts to protect life and property and to activate the response and recovery aspects of any and all applicable local or intergovernmental disaster emergency plans and to authorize the furnishing of aid and assistance thereunder; and

WHEREAS, the Board requests that the Governor of the State of Idaho, together with the other appropriate state officials, along with other appropriate federal officials, to make such declarations, and provide such assistance within County as required and allowed by law.

NOW, THEREFORE, BE IT RESOLVED, that Elmore County Board of Commissioners does hereby declare, pursuant to Idaho Code §46-1011, that a local disaster emergency exists in Elmore County, Idaho; and

BE IT FURTHER RESOLVED, that the Governor of the State of Idaho be advised of this local disaster emergency and is requested to take all action available for the amelioration of the above described local disaster emergency; and

BE IT FURTHER RESOLVED, that the Elmore County Recorder be directed to properly file this Resolution pursuant to Idaho Code Section 46-1011 and that the Elmore County Clerk provide prompt and general publicity of this declaration.

BE IT FURTHER RESOLVED, that this Resolution shall remain in effect for seven days, from September 6, 2013 through September 13, 2013, unless it is extended by the Elmore County Board of Commissioners.
