Candy Hinton appeared and reviewed the new billing procedures for the Xerox copiers.

The monthly department head meeting was held.

Wade Baumgardner, Veterans Service Officer, appeared and gave the board his monthly update. He participated in two military rites funeral for Air Force retirees. He also participated in a military rites funeral for a WWII Army veteran, who was the oldest WWII veteran in Elmore County at 97 years old. He attended the annual Service Officer training school in Boise on August 3rd and 4th. He is working a few Aid and Attendance claims for elderly veterans with limited incomes. This is a program where the VA pays a given amount to help defray the cost of care and/or residency in a nursing home or when using home health services. A Women’s Veterans Conference will be held on October 22nd in Boise, for women veterans to meet and discuss specific issues and VA interests. In June, July and August, he has assisted sixty one veterans, spouses and/or family members with their specific VA issues.

Steve Dye, Probation Services Director, appeared. Misdemeanor probation has been steady for the last few months. Juvenile probation has seen an increase, especially with pending cases. Community service hours have also picked up due to the number of juvenile cases.

Brian Chevalier, Pine EMS, appeared to update the board. He stated that scheduling still remains a challenge, as volunteering is not what it used to be. He recently removed several names from his roster because they have not volunteered in several months. He has been working with the Air Force Base and

three sites in Boise to try and recruit new volunteers. He is scheduling a “rope rescue” training class. He is also working on scheduling another sim lab in October. They were awarded grant funding from the State EMS Grant in the amount of \$108,500.00 to go toward the purchase of a new ambulance. They had a total of seven calls in June, eighteen calls in July and five calls so far for August.

Alan Roberts, Extrication Department, appeared. They are almost finished mounting the tools and equipment in the new extrication truck. Remodeling at the new extrication building is close to completion and the next step will be the electrical work. They had two calls for rollover accidents in the last week. They received a donation of eight air pack bottles from the Boise Fire Department. They had no incidents at the country music festival this year.

Carol Killian, Disaster Services Coordinator, appeared and updated the board. The table top exercise that was held in May was a precursor to the full scale exercise that was held in June, which turned out to be a large learning experience. So it was decided that another full scale exercise should be held next year. The planning for that will begin in September. She completed the grant paperwork for three grants she was working on. She has been working with Brian Chevalier on getting a generator for the Pine EMS building. The command vehicle needs some work done on the emergency break.

Bonnie Layton, Glens Ferry Economic Development, appeared and gave her monthly update. She got some feedback from businesses regarding the country music festival. Pine and Featherville saw great increases in business for the weekend. A few businesses in Mountain Home saw slight increases in business. Glens Ferry also saw an increase in business and noticed that people from the festival were coming down into town during the day. The Three Island Crossing celebration was successful. She is working on a project in Glens Ferry with the Downtown Revitalization group to reconstruct the walking path going under the railroad tracks. She will be working on a lease agreement with Union Pacific for the path and if approved, will apply for grant funding.

Bill Richey, Military Liaison, appeared. He met with Senator Crapo’s staff for a follow up meeting regarding a request for an airspace expansion. They are working with senators in Oregon and Nevada to try and lower the airspace altitude in those states to match the minimum altitude in Idaho for training purposes. The City of Mountain Home is working with the base to lease a section of the railroad that through an industrial area behind Marathon Cheese and continuing out through the base, as the city gets several requests from manufacturers looking to develop areas that are close to a rail system. The base water acquisition and pipeline project is still on track. The Bureau of Land Management (BLM) has agreed to be part of the environmental assessment, since they own most of the land that the pipeline will run through.

Alan Christy, Land Use and Building Department, appeared to update the board. Building permits have remained steady. Currently there are eighteen pending building permits, which is much higher than normal for this time of year. They will be making interactive maps available online so individuals can see

how properties are zoned and he is looking into linking building permits, conditional use permits and any other public record attached to the property.

A new extension educator will be hired in the next few months and until then there is a part time employee that has been working extra hours to assist with office duties. Hiring a new office supervisor once a new educator is in place was also discussed.

The monthly elected officials meeting was held.

Assessor Fisher's office is working on property reviews and inspection of new construction properties. They had two appeals to the Board of Tax appeals, one business and one residential.

Treasurer Sloan stated that the June tax collection went great and they collected over \$8.6 million. They are currently working on collecting the 2013 property taxes and have sent out two hundred eleven notices, which is down from last year.
