

ORDINANCE NO. 2013-01

MEETING DATES OF THE ELMORE COUNTY BOARD OF COMMISSIONERS

AN ORDINANCE ESTABLISHING THE TIMES, DATES AND LOCATIONS FOR MEETINGS OF THE ELMORE COUNTY BOARD OF COMMISSIONERS PURSUANT TO IDAHO CODE SECTION 31-710.

WHEREAS, the Elmore County Board of Commissioners (the "Board") has determined that in order to properly conduct the business of Elmore County (the "County") that the Board needs to meet more frequently than the second Monday of each month; and

WHEREAS, the Board hereby finds, determines and declares that adoption of this Ordinance is necessary to provide notice to the public of all regularly scheduled meetings of the Board and to otherwise comply with Idaho Code § 31-710.

NOW THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Elmore County, Idaho, that the following Ordinance be passed and take effect as follows:

Section 1: In January of each year, the County Clerk, at the direction of the Board, shall publish in the Mountain Home News, a list of the dates of all regular meetings of the Board for the calendar year. The meetings shall commence at 9:00 AM Mountain Time unless otherwise set forth in the published notice or in the published or posted agenda. The meetings shall be held in the Commissioner's Room in the basement of the Elmore County Courthouse, 150 South 4th East, Mountain Home, Idaho, unless the location is otherwise set forth in the published notice or in the published or posted agenda. The agendas shall be published and posted as set forth in the Idaho Open Meetings Law, Idaho Code §§ 67-2340 through – 2347 ("Open Meetings Law").

Section 2: In addition to the regular meetings, the Board may call such special or emergency meetings as it may determine as necessary according to, and as set forth in, the Open Meetings Law.

Section 3: All meetings shall be open to the public pursuant to the Open Meetings Law, except for executive sessions declared by the Board in accordance with the provisions of the Open Meetings Law.

Section 4: Should any section or provision of this Ordinance be declared by the courts to be unconstitutional or invalid, such declaration shall not affect the validity of this Ordinance as a whole or any part thereof other than the parts so declared to be unconstitutional or invalid.


Section 5: This Ordinance shall be effective upon its passage, approval and publication according to law.

This Ordinance is enacted, approved and adopted by the Elmore County Board of County Commissioners as an ordinance on this 28TH day of JANUARY, 2013.



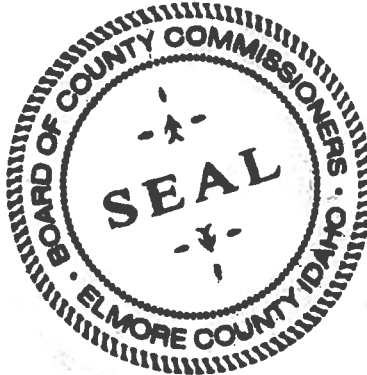

SUMMARY FOR ORDINANCE NO. 2012-03

AN ORDINANCE AMENDING THE ELMORE COUNTY ZONING AND DEVELOPMENT ORDINANCE, TITLE 6, ELMORE COUNTY CODE; TO CLARIFY LAND USE CLASSIFICATIONS; REVISING THE DEFINITION OF SLAUGHTERHOUSE AND ELIMINATING THE DEFINITIONS AND USE CLASSIFICATIONS FOR TANNERY, RENDERING PROCESSING PLANT AND MEAT PROCESSING OR PACKING FACILITY; AND REVISING LAND USE TABLES TO REFLECT SUCH CHANGES.

PASSED AND ORDAINED, at a regular meeting of the Elmore County Board of Commissioners, on September 10, 2012. This ordinance will be in full force and effect from and after its passage, approval and publication. The following is a summary of Ordinance No. 2012-03, published in compliance with Idaho Code §31-715A. A full text of this ordinance is available for public inspection in the Elmore County Recorder's Office, Elmore County Courthouse, 150 South 4th East, Mountain Home, Idaho, or at the Growth and Development Office, 520 East 2nd South, Mountain Home, Idaho. Office hours are from 9:00 AM to 5:00 PM, Monday through Friday, excluding holidays.

Summary of Ordinance 2012-03: Ordinance 2012-03 is an amendment of the Elmore County Zoning and Development Ordinance, Ordinance No. 2012-01 dated March 21, 2012 ("Zoning Ordinance") and revises the definition of slaughterhouse and eliminates the definitions and use classifications for tannery, rendering processing plant and meat processing or packing facility. Site setback requirements were established along with the addition of other requirements for slaughterhouses. The Land Use Tables contained in the Zoning Ordinance were revised to reflect the elimination of the terms tannery, rendering processing plant and meat processing or packing facility and the revision to the term slaughterhouse.

SECTION 1. ADOPTION OF THE AMENDED AND RESTATED ELMORE COUNTY ZONING AND DEVELOPMENT ORDINANCE: Ordinance 2012-03 is hereby adopted as an amendment to the Zoning Ordinance. The Zoning Ordinance shall remain in full force and effect as amended by Ordinance 2012-03.

SECTION 2. EFFECTIVE DATE. Ordinance 2012-03 shall take effect and be in force after its passage, approval and publication as required by law. In lieu of publication of the entire Ordinance, a summary thereof in compliance with Idaho Code § 31-715A may be published.

Ordained and enacted by the Elmore County Board of Commissioners as Ordinance 2012-03 on September 10, 2012.
