

RESOLUTION NO. 790-21

A RESOLUTION CONFIRMING THAT THE BUILDING AND FIRE CODES ADOPTED BY THE STATE OF IDAHO FOR STATEWIDE APPLICATION, EFFECTIVE JANUARY 15, 2021, ARE IN EFFECT IN ELMORE COUNTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Idaho Building Code Board of the Division of Building Safety, as authorized by Idaho Code § 39-4107, has adopted, with amendments, effective January 1, 2021, the following codes published by the International Code Council:

2018 International Building Code, per section 39-4109(a) and as amended by IDAPA 24.39.30.004.01;

2018 International Residential Code, per section 39-4109(b) and as amended by IDAPA 24.39.30.004.02;

2018 International Existing Building Code per section 39-4109(d) and;

2018 International Energy Conservation Code, per section 39-4109(c) and as amended by IDAPA 24.39.30.004.04; and

other construction and safety-related model codes or standards referenced in the above adopted codes and not adopted by the state of Idaho, to be construed as pertaining to the equivalent code or standard that has been duly adopted by the state of Idaho; and

WHEREAS, pursuant to Idaho Code § 41-253, Idaho has adopted the International Fire Code and appendices, and the State Fire Marshal, as authorized by Idaho Code § 41-254, has adopted the 2015 International Fire Code and appendices, as amended by IDAPA 18.08.01, as the minimum standards for the protection of life and property from fire and explosions in the state of Idaho; and

WHEREAS, pursuant to Idaho Code § 39-4116, the Board of County Commissioners has adopted Elmore County Code § 9-1-1 and 9-1-2, prescribing the codes published by the International Code Council, including subsequent versions adopted, as amended, by the Idaho Building Code Board of the Division of Building Safety, as set forth in IDAPA 24-39.30.004 and the State Fire Marshal, as set forth in IDAPA 18.08.01; and

WHEREAS, pursuant to § 9-1-1, the Board of County Commissioners may confirm the building codes in effect in Elmore County by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ELMORE COUNTY IN LAWFUL MEETING:

Section 1. The following building and fire codes adopted by the state of Idaho for statewide application are confirmed as the building and fire codes in effect in Elmore County as of the January 1, 2021:

2015 International Fire Code, as amended by IDAPA 18.08.01;

2018 International Building Code, per section 39-4109(a) and as amended by IDAPA 24.39.30.004.01;

2018 International Residential Code, per section 39-4109(b) and as amended by IDAPA 24.39.30.004.02;


2018 International Existing Building Code per section 39-4109(d) and;
2018 International Energy Conservation Code, per section 39-4109(c) and as amended by
IDAPA 24.39.30.004.04; and
other construction and safety-related model codes or standards referenced in the above adopted
codes and not adopted by the state of Idaho, to be construed as pertaining to the equivalent code
or standard that has been duly adopted by the state of Idaho.

Section 2. That this Resolution shall be in full force and effect immediately upon its
adoption and approval.
