#### **Amended Executive Summary:**

#### Paragraph 7:

Therefore, it is staff's recommendation that CUP 2015-10 be revoked and a new CUP process be initiated by the incoming site operators, Pacific Steel & Recycling. Elmore County staff will continue to work with Pacific Steel & Recycling in the interim in order to, <u>develop a Remediation Plan within 30-days of the revocation with Pacific Steel and Recycling for addressing Elmore County's Notices of Violations at the Site and to bring the site into compliance before a new CUP application is made.</u>

help draft a proper remediation plan that will be included in the future proposed CUP. Pacific Steel & Recycling understands that an interim remediation plan will be necessary while the site does not have an operational CUP.

#### **Amended Staff Recommendation:**

Based on the evidence presented at the public hearing, exhibits of record, and Department's analysis above, Department staff recommend that the Planning and Zoning Commission vote to revoke CUP 2015-10 and require that Pacific Steel & Recycling work with Staff to draft a Remediation Plan within 30 days of the revocation of CUP 2015-10 and prior to the submittal of a new CUP to operate the site. initiate a remediation plan and begin application for a new Conditional Use Permit as the new site operators.

Dear Mr. Roddin:

As you know, Pacific Hide & Fur Depot dba Pacific Steel & Recycling ("Pacific") was the successful purchaser of the assets of 2X. Pursuant to our conversation with the County, the following is our anticipated timeline for the removal and remediation of the 2X Tire Recycling and Tire Sorting/Recycling Facility:

- Week of September 29<sup>th</sup>, a Pacific branch manager will travel to the site to evaluate the trailers. We will determine which trailers we wish to keep, which trailers are DOT worthy, which trailers are road worthy or can be moved via lowboy.
- The following four to eight weeks, Pacific will move trailers off site and remediate tires. Pacific anticipates having the 2X site cleaned up in approximately eight weeks.
- Mike Eisenman has agreed to allow Pacific to store trailers Pacific wishes to keep on his property.
- Pacific will work to get the tire shredder operational. Pacific has hired Phoenix Industries to conduct repairs. The timeline is dependent on parts and the schedule of Phoenix Industries. We anticipate it could take 12 months to have the tire shredder fully operational.
