# **Completing the Declaration of Candidacy**

When completing the Declaration of Intent, be sure to complete all fields and questions. Any incomplete or missing information may void your filing.

#### **Section 1: Office Information**

Enter one of the following special district offices.

#### May Election:

#### November Election:

- Ambulance Service District Commissioner
- Cemetery
- · Fire Protection
- Recreation

#### **Section 2: Candidate Information**

Enter your name as it appears on your voter registration.

A phone number is required and will become publicly available upon request.

#### Section 3: Registered Address

- · This MUST be a physical address. P.O. Boxes will not be accepted.
- · If your registered address is the same as your mailing address, check the box at the bottom of this section and skip section 4.

#### Section 4: Mailing Address

- · P.O. Boxes are acceptable.
- · If your mailing address is the same as your registered address, check the box at the bottom of section 3 and leave this section blank.

#### Section 5: Homeowner's Exemption

If you or your spouse have claimed a Homeowner's exemption, list the address in this section.

#### Section 6: Campaign Finance

If your campaign finance contributions or expenditures exceed \$500, you MUST create a campaign finance account with the Idaho Secretary of State.

## **Instructions for Certification**

Upon receipt of both the Declaration of Candidacy and the Petition of Candidacy:

- 1. Stamp or write the date and time of receipt on the front of the Declaration of Intent.
- 2. Complete the fields and statement below.
- 3. Transmit a copy of this Certification AND a copy of the Declaration of Intent to the County Clerk for ballot preparation.

#### **IMPORTANT**

- 1. Verification of the candidate's qualifications should occur immediately upon receipt of the filing. This allows the candidate time to correct any errors in the filing.
- 2. Certification to the County Clerk should occur upon the verification of the candidate's qualifications. To assist the County Clerk in election preparation, do not HOLD these until the last day of filing.
